# IMPORTANT NOTICE BOILERMAKER PENSION SPECIAL FUNDING REALLOCATION WAGE AND BENEFIT SCHEDULE(S) – EFFECTIVE JULY 15, 2018

### Pension Special Funding Contribution

The BCA has been advised that the International Brotherhood of Boilermakers will be reallocating the Boilermaker Pension Special Funding amounts as follows:

### Local 128 - Ontario

- \$1.00 to Health and Welfare
- \$1.24 to the hourly wage rate (less adjustments to maintain the Vacation and Statutory Holiday pay)

### Local 146 - Alberta

- \$1.00 to Health and Welfare
- \$1.00 to the hourly wage rate (less adjustments to maintain the Vacation and Statutory Holiday pay)

### Local 203 – Newfoundland and Labrador

- \$1.00 to Health and Welfare
- \$0.50 to the hourly wage rate (less adjustments to maintain the Vacation and Statutory Holiday pay)

### Local 555 – Saskatchewan and Manitoba

- \$1.00 to Health and Welfare
- \$0.62 to the hourly wage rate (less adjustments to maintain the Vacation and Statutory Holiday pay)
- As previously communicated on June 27, 2018 in the BCA/IBB Local 555 Settlement notice, the Wage and Benefit Schedule has been amended to include the addition of:
  - \$0.25 for Educational Training
  - \$0.16 for Job Ready Dispatch
  - \$0.25 for Health and Welfare
  - Saskatchewan Subsistence Rate \$135 / day worked
  - Manitoba (South of the 53<sup>rd</sup> Parallel) Subsistence Rate \$135 / day worked
